

Whenever the Institution or Organisation is called upon to do so.
6. All payments to be transferred to all beneficiaries(including all vendors and students) by RTGS only & no payment will be made in cash
7. The domestic Travel by Air-India in refundable economy class is admissible under travel expenses as per GOI norms. There will be no international travel undertaken from the grant release under the project.
